Voucher codes and Discounts

All vouchers and codes are valid for the specified dates communicated with each voucher code.

1. Promotional Vouchers:

1.1 "Voucher code" refers to a code issued to participants in the Irish Juice Cleanse Challenge which entitles the participant to redeem specified benefits or special offers when making a purchase from a specified merchant. We accept no responsibility for the content or validity of any voucher advertised.

1.2 All Vouchers codes are promotional codes for participants who have paid to take part in the Irish Juice Cleanse Challenge which entitle them to discounts of 'partner' online store. These Voucher codes are subject to any terms, restrictions and conditions associated with the respective voucher by the merchant/advertiser.

1.3 All Promotional Vouchers and voucher codes have redemption period of no less than 2 months from the 1/12/2014 During this time the customer can redeem the discount on the indicated items by supplying the code at the checkout when buying on our partner's online stores.

Any disputes that arise regarding the redemption of a promotional voucher code is solely between the partner/merchant/advertiser and the individual user.

2. Terms of use of discount vouchers and voucher codes

2.1 You must be at least 18 years old to take part in the Irish Juice Cleanse Challenge.

2.2 By clicking on the "buy now/paynow/submit" button you submit an offer to Real Health Revolutions Ltd to purchase the material associated with the Irish Juice Cleanse Challenge event. However, the purchase is not complete until you receive an email from Irish Juice Cleanse Challenge confirming acceptance of your offer. Irish Juice Cleanse Challenge expressly reserves the right to reject your offer. In addition, even if Irish Juice Cleanse Challenge has accepted your offer, it can cancel the contract at any time if it reasonably suspects that you have committed or that you may be committing any fraud against Irish Juice Cleanse Challenge, an affiliated third party of Irish Juice Cleanse Challenge or the Merchant.

2.3 The Merchant may have its own terms and conditions applicable to the sale, supply and/or provision of the Merchant Offering.

3. Redemption of a Voucher

3.1 Unless expressly stated otherwise:

(a) the Voucher/Voucher code can only be redeemed once;

(b) the Voucher/Voucher code can only be redeemed with the Merchant and not with Real Health Revolutions Ltd;

(c) the Voucher/Voucher code is valid for one person only; and

(d) you must follow the redemption instructions associated with the Voucher when you redeem the Voucher with the Merchant.

5. Cancellation (and exceptions), Refunds and Problems

5.1 You have a statutory right to cancel your purchase of the Voucher within 14 calendar days after the day you receive the confirmation email (the "Voucher Cancellation Period"). However, if you redeem your Voucher during the Voucher Cancellation Period, you expressly request the Irish Juice Cleanse Challenge to begin providing the services to you, and you acknowledge that you lose your right to cancel the purchase of the Voucher. Since the Irish Juice Cleanse Challenge is not responsible for the supply or provision of the Merchant Offering, once your Voucher is redeemed the Irish Juice Cleanse Challenge has completed its services to you in full. Please note that, for the avoidance of doubt, this section also applies to all "Direct Checkout" deals.

5.3 If you cancel your purchase of the Voucher in accordance with this section 5, the Irish Juice Cleanse Challenge will refund you for all payments made as part of your purchase within 14 calendar days from the day on which you informed the Irish Juice Cleanse Challenge about your cancellation.

5.4 If you have been unable to redeem your Voucher with the Merchant before the expiry of the Redemption Period through no fault of your own, you may be entitled to a refund. In order to receive a refund, you must prove to the Irish Juice Cleanse Challenge reasonable satisfaction that your inability to redeem the Voucher was not your fault. The decision to grant a refund is within the sole discretion of the Irish Juice Cleanse Challenge.

5.5 If you redeem your Voucher, but the Merchant has not properly provided you with the Merchant Offering, or if you have a complaint regarding the provision of the Merchant Offering, you must take action against the Merchant directly.
